- Based on the State’s Fiscal Year of July 1 of one year through June 30 of the next year.
- The Problem Gambling and Addictions Grant Fund is administered by the Kansas Department for Aging and Disability Services (formerly the Kansas Dept. of Social and Rehabilitation Services).
- Boot Hill Casino: 1.5% each to Dodge City and Ford County;  
Kansas Star Casino: 1% each to City of Mulvane, Sumner County, and Sedgwick County;  
Hollywood Casino: 3% to the Unified Government of Wyandotte County & Kansas City, KS;  
Kansas Crossing Casino: 1% each to City of Pittsburg, Cherokee County, and Crawford County
- From the Casino Manager’s fees each casino manager is responsible for paying all of its expenses related to the casino, including but not necessarily limited to: contractual payments for the facility itself; utilities; purchase or lease of all gaming machines and equipment on behalf of the State of Kansas; employee expenses; fees for the central computer system and slot management system providers; certain expenses of the Kansas Lottery and the Kansas Racing and Gaming Commission; taxes; insurance; and, other obligations per law and the manager’s contract with the Kansas Lottery.
